1. Deposits, Honorarium, and Cancellations:

Deposits: Non-refundable if the client cancels. If the artist cancels, rescheduling or reimbursement of the deposit will be offered if mutually agreed upon.

Honorarium: Must be cancelled before 30 days before a full reimbursement is provided, after 30 days, a partial reimbursement may only be valid upon mutual agreement.

If acts of God occur where we can find a date that is doable, we will do our best to reschedule, however note that travel fee maybe repaid again.

2. Travel and Lodge Costs: Non-refundable if the client cancels. If the artist cancels (excluding acts of God), reimbursement may be possible based on mutual agreement and third-party insurance claims.

Quoted fares and lodging rates are subject to change. Any additional fees due to changes by third parties will be the responsibility of the purchaser.

3. Payment Terms:

Deposit: Required within 24 hours of booking confirmation. Dates are not held without this deposit and signed agreement.

Honorarium: Due 30 days before the event, unless otherwise agreed in writing.

4. Force Majeure: Neither party is liable for failure to perform due to events beyond their control. Rescheduling is the only option, and refunds are not available.

5. Sickness and Accidents: If the artist cannot perform due to sickness or accident, the honorarium will be refunded, but deposits and travel expenses are non-refundable.

6. Promotion and Production:

The purchaser is responsible for all aspects of promotion and production, including venue rentals, security, and advertising. Any promotional material, such as flyers, must meet Kingdom Muzic's standards for quality. If the provided material does not comply with these standards, the talent reserves the right to create their own promotional materials at their discretion without penalty.

The purchaser will promote the event and share all promotional materials with the artist. The artist must approve the use of their name, image, and recordings in advertising.

7. Tickets and Sales:

Use <http://SEETICKETS.US> for ticket sales. The artist receives 25% of net sales, and the purchaser receives 75%.

Free admission must be coordinated with the Kingdom Muzic Manager.

8. Merchandise Sales:

The artist will retain 100% of the gross revenue from merchandise sales and will not share any portion with the host. The purchaser is responsible for providing a designated space with a table and chairs for the artist to sell their merchandise.

9. Recording and Streaming:

The purchaser cannot record, broadcast, or stream the artist's performance without prior written consent. The artist may record the performance for their own use.

10. Technical Requirements:

Details of sound and lighting equipment/services will be outlined in a Technical Rider attached to the contract.

11. Green Room and Hospitality:

The purchaser will provide a safe, clean dressing room with locks and refreshments for the artist and crew.

12. Security:

The purchaser will ensure adequate security for the artist and the venue and will be responsible for any theft or damage to the artist's equipment.

13. Pyrotechnics:

No pyrotechnic devices are allowed without written consent from either parties. The purchaser is responsible for permits and fire safety.

14. Independent Contractors:

The artist is an independent contractor, responsible for their own taxes. The purchaser controls the performance schedule, while the artist controls the performance details.

15. Insurance:

The purchaser shall obtain and maintain, at its own expense, adequate personal injury and property damage liability insurance coverage, including all activities related to the

Artist’s engagement and performance, from setup to takedown. The Purchaser assumes all responsibilities and liabilities for any claims or damages.

16. Agreement Terms:

This agreement cannot be assigned without the artist's written consent.
It constitutes the entire agreement and is governed by Texas law. Disputes will be resolved in Texas courts.

17. Severability:

If any part of this agreement is invalid, the rest remains effective.

18. Representative Authority:

The representative signing this contract confirms they are authorized to do so and that the artist agrees to the terms.
